The PDAC has determined that the features and function of the VELPEAU IMMOBILIZER with the waist strap is most closely described by the L3670's sling and swathe in the advisory article, PDAC - Correct Coding of Elbow, Shoulder, Shoulder-Elbow-Wrist-Hand and Shoulder-Elbow-Wrist-Hand-Finger Braces (Orthoses) (dmepdac.com), see below:

L3670 (SHOULDER ORTHOSIS, ACROMIO/CLAVICULAR (CANVAS AND WEBBING TYPE), PREFABRICATED, OFF-THE-SHELF) describes a prefabricated OTS product designed to support and immobilize the shoulder in multiple planes using a swathe and sling design. Product is made primarily made of canvas and webbing type materials. This is a complete device and no add-on codes may be billed for this orthosis.

In addition if the waist band is not required for use, no HCPCS code is assigned to the VELPEAU IMMOBILIZER, and it will not be billable to the DME MACS.

Please note that your application was still missing the FDA 510(K) Number (and letter), or Exemption Regulation Number if exempt even after our request for you to provide it to us. In future applications to the PDAC, ensure that all required documentation is provided at time of submission or your application may not be processed.

If you disagree with this decision, you may request a reconsideration within 45 days of the letter's date and provide evidence to substantiate a reconsideration of PDAC's original coding determination. If your request for a reconsideration is made after the 45-day time frame, it will require a new application and documentation to support the request.
